Description: Here's your opportunity to purchase a feedlot, currently permitted for 3,200 head, sitting on 160 acres of land. It's conveniently located in the middle of cattle country on the Stanton/Cuming County line, and only 1 ½ miles off HWY 15. The feedlot was last used in early summer, and the new owner would have the opportunity to purchase silage separately which is located on the property so they could start feeding right away. There are approximately 88 acres of cropland total on the quarter, 51 acres of that being pivot irrigated. The 6-tower Zimmatic pivot, nozzeled for 700 gpm, is included in the sale and is set up for either ground water, which is supplied submersible well, or lagoon water, which is setup with a diesel power unit, pump w/screen, and 500-gallon fuel barrel. Also included is a modern open front commodity shed, bulk tanks with pumps, 1,400 sq. Ft. home, 60 X 40 shed and working facilities. There is a complete computer system used to run the nutrient rations on location that's not included in the sale but may be able to stay if you continue with the current supplier. All the bunks, gates, panels and watering systems on location will stay. Please note, the pivot does overhang the neighbor to the east. Take a look at this property today!




