

The problem is the controller opens and closes the ground for the relay that operates the light with the controller plugged in there is a ground all the time why the light stays on. If it is unplugged the wire test good with no shorts to ground. You can't get just the CCU i will have to get a CCU/PCU and this will mean the transmission will need to be calibrated as well.

Got a "new" CCU/PCU and installed it to find that it had been used and I couldn't change the engine hours to match this tractor. Talked to dawn and she made a parts case, they wanted it returned and would send a different one.

Install the second CCU/PCU and input all addresses that where need to make it work on this tractor. All data saved how I had it. Tested the lights and they worked as they should. Took the tractor out and warmed the oil then ran the calibration 3 times to get the best cal. Tested on the lot and it shifted very nice. Cleared all codes that where stored.

Well i was heating the oil i found that SCV #1 was leaking oil. Moved to a different SCV to continue the calibration, looked into the problem and fixed it on segment 4.
