Customer complaint:

Left rear outside idler but fell off idler axle.

Resultant damage:

Idler hubs needing replaced.

Cause of failure:

Darte

wear and bearings in the idler hubs getting full of water and failing

Repair process comments:

Had to have machine washed before bring in shop for repairs. Moved machine in shop and put machine on jack stands. Inspected axle and found the threads were stripped and the axle needed to be replaced. Removed track and removed drive motor swing frame. Removed inside hub and axle. Installed new axle and installed the drive motor swing frame back on axle, installed two new axle hubs with new lock nuts and caps. Installed original idler wheels as they were ok. After talking to customer they decided to do the rest of the idle hubs. Repeated the prosses for the left front and both front and back on the right side. Was able to reuse the other three idler axles. Also replaced a hand full of idler wheel bolts as they were worn and also replaced the front scrapers as the home made ones that were on the machine were not held on very well and were getting into the old hubs. Installed tracks and recentered the tensioners as they were only extended on one side. Tightened tracks and drove machine. Checked track tension and checked over drive motor hoses for leaks and non were found after repairs.
