replaced drive motor.

#### Cause of failure:

seal in drive motor failed due to age and debris.

#### Repair process comments:

checked out machine and found oil leaking between motor housing and sprocket flange. talked with customer and with hours on machine and age of motor ordered new drive motor. ordered new drive motor, went back and removed track, removed sprocket, removed lines going to drive motor, removed drive motor form machine, swapped fitting over to new motor, installed new motor back on machine, hooked lines back up, installed sprocket on motor, installed track back on machine, tightened now track, filled hydraulic reservoir, started machine and checked for leaks, no leaks were found returned machine back to service.
